- I. **Call Meeting to Order:** Meeting is called to order at 6:36PM. (Jacy Herman) JH, (Natalie Sallee) NS, (Elaine Siegel) ES, (Martha Gaines) MG, (Debby Braun) DB are present. Also in attendance are (Shama Jacover) SJ and (Dr. Patricia Efiom) PE. Absent (Iden Nowlin) IN
- II. **Citizen Comments:** There are no citizens present at this meeting
- III. **Approval of Minutes:**
 - a. **April 15, 2021:** DB motions to approve; NS seconds the motion; all approve (DB, NS, MG, ES, JH)
- IV. **Old Business**
 - a. **Social Media Posts (Sallee):** ES suggests a social media post regarding the chalk graffiti; NS requests ideas for how to post about this issue; MG questions the relevance of the topic; discussion about response; PE encourages committee to reflect on intention; JH requests photos and to be aware of tension surrounding police involvement/reform; PE suggests building a relationship with the church as a concerned neighbor; MG suggests formal, continuous documentation of the graffiti;
